OWNER/TRAINER LARRY DEAN DONLIN SR, AFTER (RECEIVING PROPER NOTICE AND WAIVING HIS RIGHT TO A FORMAL HEARING) AND APPEARING BEFORE THE BOARD OF STEWARDS ON THURSDAY, MARCH 21, 2024 AT FONNER PARK IS HEREBY SUSPENDED 15 DAYS AND FINED \$300.00 DOLLARS FOR A VIOLATION OF NEBRASKA RACING & GAMING RULES 9.001.04 (THE FILLY EMERYANDAVERY WAS NOT QUALIFIED TO START BECAUSE IT HAS NOT BEEN OR CONTINUES TO BE PROPERLY ENTERED THEREIN;) AND 12.007.07 (FAILURE TO HAVE THE HORSE GAME TO PLAY IN THE PADDOCK FOR THE 4TH RACE AT FONNER PARK ON MARCH 17, 2024 AT THE TIME APPOINTED)

AFTER CONSIDERATION OF MITIGATING CIRCUMSTANCES, MR. DONLIN'S 15 DAY SUSPENSION IS HEREBY STAYED PENDING NO FURTHER VIOLATIONS DURING THE FONNER PARK 2024 RACE MEET.

IT IS FURTHER ORDERED THAT THE REVISED ORDER OF FINISH FOR THE 4TH RACE ON MARCH 17, 2024 AT FONNER PARK IS AS FOLLOWS: 1ST - #5 GEORGIANO, 2ND - #7 TAPIT'S LADY, 3RD - #6 RUNAWAY A. TRAIN, 4TH - #1 KISS RIDE GOODBYE, 5TH - #2 SHE'S MY PRIORITY, 6TH - #4 SUNSHINE EMILY, 7TH - #8 CAL'S GIRL, 8TH - #3 EMERYANDAVERY

THE HORSEMEN'S BOOKKEEPER IS DIRECTED TO MAKE THE NECESSARY CHANGES TO THE PAYMENT OF PURSES FOR THE SUBJECT RACE. IF GAME TO PLAY'S SHARE OF THE PURSE HAS BEEN PAID, IT IS HEREBY ORDERED RETURNED TO THE HORSEMEN'S BOOKKEEPER.

THIS RULING DOES NOT AFFECT THE PARI-MUTUEL PAYOFFS.
