FOR FOR THE HORSE UNDER HIS CARE AND CUSTODY, "WANTABE", SECOND (2ND) PLACE FINISHER IN THE SIXTH (6TH) RACE AT FONNER PARK ON SUNDAY MARCH 2,2025, TESTING POSITIVE FOR THE PROHIBITED SUBSTANCE "METHOCARBANOL" AT 2.09 NG/ML. IN THE BLOOD.

IT IS THE ORDER OF THE BOARD OF STEWARDS THAT OWNER/TRAINER GREGORIO RIVERA BE AND IS HERBY FINED THE SUM OF TWO HUNDRED FIFTY DOLLARS (\$250.00).

FURTHERMORE, THE SIX YEAR OLD GELDING "WANTABE" IS ORDERED DISQUALIFIED FROM SECOND (2ND) PLACE AND SHALL REMAIN UNPLACED IN THE SIXTH (6TH) RACE AT FONNER PARK ON SUNDAY MARCH 2, 2025.
