FOR THE HORSE UNDER HIS CARE AND CUSTODY, "WATER TESTER", SECOND (2ND) PLACE FINISHER IN THE NINTH (9TH) RACE AT FONNER PARK ON SATURDAY, APRIL 12, 2025, TESTING POSITIVE FOR THE PROHIBITED SUBSTANCE 2-(1-HYDROXYETHYL) PROMAZINE SULFOXIDE CONFIRMED IN URINE AT 287 NG/ML.

IT IS THE ORDER OF THE BOARD OF STEWARDS THAT OWNER/TRAINER MARK HIBDON BE AND IS HEREBY FINED THE SUM OF FIVE HUNDRED DOLLARS (\$500.00).

FURTHERMORE THE THREE YEAR OLD COLT "WATER TESTER" IS ORDERED DISQUALIFIED FROM SECOND (2ND) PLACE AND SHALL REMAIN UNPLACED IN THE NINTH (9TH) RACE AT FONNER PARK ON SATURDAY, APRIL 12, 2025.


