The Applicant acknowledges and agrees that the Applicant must accept any risk of adverse public notice, embarrassment, criticism, other action, or financial loss that may result from action or inaction by the Commission with respect to any application, and that the Applicant expressly waives any claim for damages resulting thereof. The Commission may further request information not requested in this form or in addition to that which is provided in response to this form. The Applicant acknowledges and agrees that the Applicant shall provide all information, documents, materials, and certifications at the Applicant's sole expense and cost.
- B. The Applicant acknowledges and agrees that the Applicant must make accurate statements and include all material facts and that any omissions, material errors, misrepresentations, failure to provide any requested information, or failure to meet any other requirement as set forth in law, rule, or regulation may result in the denial of the Application, suspension or revocation of any license issued by the Commission, or issuance of fines or penalties.
- C. The Applicant (and in the event a license is issued, the Licensee) acknowledges and agrees that pursuant Nebraska Adm. Code Title 296 rule 3.003.01, certain individuals associated with the Applicant, or a Holding Company of the Applicant will be required to apply for and obtain Key Employee Licenses, which is a separate and distinct process. Further, approval of a Key Employee License does not ensure approval of a Gaming-Related Vendor License, and vice versa.

The Applicant or Holding Company (and in the event a license is issued, the Licensee) acknowledges and agrees that any license issued by the Commission is a revocable privilege and is not transferable or assignable in any manner whatsoever. Further, no licensee has a vested right in or under any such license.
